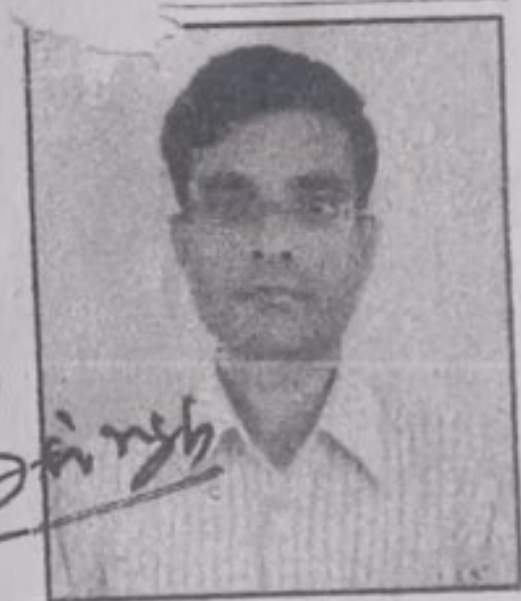

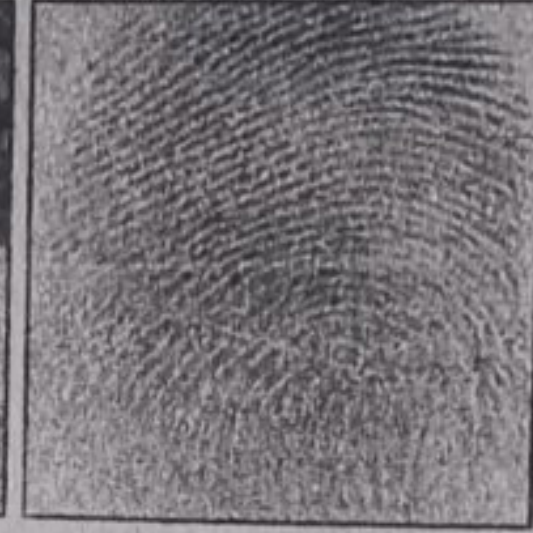

This DEED OF DECLARATION OF TRUST is made on this the 02/09/2022

SHRI ANURAG MISHRA aged about 56 years S/o Shri Mani ram Mishra R/o A – 92 Avas Vikas Colony Budaun (U.P.), hereinafter called as the Author of the trust (which expression unless repugnant to the context or meaning thereof includes her heirs, executors. And administrators, etc.)

WHERE the Executant SHRI ANURAG MISHRA is desirous of creating a TRUST for Charitable purposes of property mentioned in schedule given at the foot of this deed and which have been acquired by her personal Labour and which belongs to the entirely and absolutely.

AND WHEREAS the Executant has appointed SARVA SHRI –

NOW THIS DEED WITNESS AS UNDER: -

1. For effectuating the said desire and in consideration of the premises the Authors oath hereby pay, transfer and handover unto the trustees the said amount of Rs. 50,000/- (Rupees Fifty Thousand Only) and all the estate, right, interest, claim and demand whatsoever at law and equity of the Author of in and to the said amount of Rs 50,000/- (Rs Fifty Thousand Only) hereby paid, transferred and handed over unto the Trustees for ever upon the Trust and with the subject to the powers, provision agreements and declarations hereinafter appearing and contained of and concerning the same.
2. The trustees shall hold and stand hold and stand possessed of the said amount of Rs. 50,000/- (Rupees Fifty Thousand Only) hereinafter for the brevity's sake referred to as "TRUST FUND" which expression shall also include cash and all the other amount and other property, whether movable or immovable (self-acquired/purchased/donated), and investments by way share, fixed deposits, Government securities, bonds debentures, all voluntary grants and contributions, or in any other from that the Trustees may receive and hold by way of acquisition, donations, gifts or otherwise howsoever upon the Trust into which the same or any other part thereof might be converted, invested or varied from time to time or come to their hands by virtue of these presents, upon the trusts and with the subject to the powers, provisions agreements and declarations hereinafter declared and contains of the concerning the same.

3. That the trustees have to perform the obligations entrusted to them and will be entrusted to them in future under this deed.
4. That the trustees shall hold and stand possessed of the Trust Funds upon the following Trust:

That the trust hereby created shall be called and known as "DHANDEVI MANIRAM MISHRA TRUST" The Board of Trustees shall not be empowered to change the name of the Trust in any eventuality.

Area of Operation: The area of operation of this Trust will be whole of India but preferably in the state of Uttar Pradesh. The area of operation may be enlarged or emended by the Trustees as per the requirements of the future.

Office: The registered office of the Trust will be for the present situated at A – 92 Avas Vikas Colony Budaun (U.P). The Trustees may open branches or local offices at different places within the area of operation.

5. **Nature of Trust:** Trust shall be charitable Trust in nature and no part of the corpus fund, under any circumstances, whatsoever, be paid, or lent, or revert to the Author or Trustee/s, their heir/s, nominee/s, descendant/s, legal representative/s, assignee/s, save of furthering the objectives of the Trust.
6. **Objectives:** Among other, the objectives of the Trust shall be:
 - (a) To work for the betterment and upliftment of society without any discrimination or distinction on the basis of caste, creed religion language, colour, sex, etc.;
 - (b) To promote education & to establish, run & maintain school's colleges & institutes for imparting all type of education;
 - (c) To establish run & and maintain a range of technical and non – technical & professional education/vocational institutions college etc; and

- (d) To establish, run & maintain sports college gymnasium, swimming pools and provide all types of infrastructure & facilities for promotion of sports; and
- (e) To promote religious spiritual activity; and
- (f) To Promote organic farming; and
- (g) To promote conservation of environment (soil, water, etc); and
- (h) To establish & maintain hotels & boarding house & coaching institutions & residential accommodation for the student's getting education and those connected with the institutions; and
- (i) To provide stipend, scholarship & prizes to the students & to help poor & deserving students; and
- (j) To engage teachers, professors, instructors & experts of good moral character, capable of imparting education to the students in modern sciences, industrial avocation research work technical, intellectual and other usual pursuits; and
- (k) To develop healthy as well as critical attitude towards the development of mental, physical & moral uplift of the students & those connected with the institutions to make them a better human being & a good citizen; and
- (l) To charge moderate tuition fee; and
- (m) To provide opportunities for research in technical, non – technical and vocational field; and
- (n) To endeavor to make the students think beyond the distinctions of caste, creed, colour, religion, sex, language, etc. and facilitate their transformation into a good Indian Citizen; and

- (o) To serve the society by giving the financial aid to the needy & destitute people, orphans, widows & aged persons; and
- (p) To establish, run & maintain Dharamshala's, Jalshalas, Ashrams, Orphanage, Charitable Dispensaries, Libraries & Public Halls etc; and
- (q) To work for the cause of environment, pollution control & better living; and
- (r) To establish & develop institutions for the physically handicapped, disabled & mentally retarded persons their education, food, clothing & other help; and
- (s) To grant relief & assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire, pestilence, etc. and give donation and other assistance to institutions, establishments or persons engaged in such relief work ; and
- (t) To start employment-oriented programmes in rural as well as urban area of the India; and
- (u) To promote Indian Culture & social civilization by performing and promoting various activities; and
- (v) To establish, run & maintain Blood Bank, Diagnostic Labs, OPD Clinics and Hospitals on charity basis; and
- (w) Generally, to do all and such other acts and things as are consequential, incidental and/or conducive for the attainment of the aforesaid or any other objective/s and/or required to be performed for adherence to the provisions of applicable laws and statutes.

7. **Trustees:** Mean and include only First Trustees who shall be life members of the Trust.

- Each First Trustee shall be entitled and empowered to nominate one person among his heirs during his/her life time, who will take over as a lifelong

trustee, after the former expires or resigns for any reason whatsoever. In the event of death of First Trustees without nominating the another, one of the legal heirs of that Trustee, who may preferably elder male heir, must be selected as Trustee by the Board of Trustees with the consent of all other Trustees.

- **Termination of Office of the Trustees:** If the Trustee/s hereby appointed or any of them or any future Trustee/s shall cease to hold office:
 - a. If he dies.
 - b. If he resigns
 - c. If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
 - d. If it is found to have acted against the interest of the Trust.
 - e. If it is unanimously decided by the Trustees specified in para(d) above that his continuation in the office is against the interest of the Trust.
 - **Number of Trustee:** The number of the Trustees shall not be less than two and more than eleven. If the number of the Trustees fall below two, the Trustees shall not, Except for the purposes of filling any vacancy, act so long number is below the said minimum.
8. **Office Bearers:** The Trust shall be managed by the Managing Board and its constitution will be decided by the Trustees time to time for ensuring a smooth running of the affairs of the Trust. No Trustee shall be eligible to be elected for two posts simultaneously.

The first Office Bearers of the Board of Trustee shall be as mentioned below:

President : Shri Maniram Mishra

Vice President : Smt. Dhan Devi

Secretary/Founder Trustee : Shri Anurag Mishra

Joint Secretary : Shri Alok Mishra

Treasurer : Smt. Purnima Mishra

- **President:** - President will be responsible for holding meeting.

He will preside over all meetings of Trust. He will advise to Board of director/Trustees' time to time for welfare of Trust.

He will act like visionary for Trust.

- **Vice President:** - In the absence of president vice president discharge all of president duties.

He will also work in the welfare of Trust.

- **The Secretary/Founder Trustee**

The day – to – day administration of the Trust shall be looked after by the secretary under the guidance, control and supervision of the Board of Trustees.

The Secretary shall be empowered to operate accounts, in the name of the trust, with bank/s, post office/s and other financial institution/s, besides exercising any other powers, functions or duties as specifically entrusted to him in writing by the Board of Trustees for achieving the objects of the Trust and shall be empowered to do all such acts as trust can do. And shall cause a Minute Book of the proceeding of the meetings of the Board of Trustees to be maintained.

All the decisions vis – a – vis the affairs of the Trust will be taken unanimously by the consent of all the board of Trustees.

In case of difference of opinion among the Trustee. The decision of secretary/founder trustee will be final and his discission will prevail on all Trustee.

- **Joint Secretary:** - Joint Secretary will perform duties and allegations of secretary in his absence.

But he will not be eligible for taking police decision, and take care records and documents.

- **Treasurer:** - He will operate accounts for Trust in absence of Secretary. He will maintain.

9. **Meeting of Board of Trustees:** The Trustees shall hold, and the secretary/founderTrustee may convene as many meeting for transacting business, as may be necessary, but at least two meeting in a financial year shall always be held. One of which be annual meeting wherein budget of that year and accounts of previous year shall be submitted. The annual meeting shall be held within six months of close of the accounting year. If Trustee cannot come physically for meeting than virtual meeting will be applicable.

- **Notice:** Three days' Notice shall ordinarily be given in writing for a meeting of Board of Trustees.
- **Quorum:** The quorum for the Meeting of the Board of Trustees shall be Two members or 1/3 of total trustees whichever is higher. Quorum is not required for a meeting adjourning for want of quorum.

10. Power & duties of Trustees:

- (a) To improve and add to the Corpus of the Trust by accepting donations, contribution by way of cash or n kind in the shape of any movable or immovable assets for and on the behalf of the Trust and hold the same for the Trust; and
- (b) To acquire or purchase or Lease or Rent any Land or Building & to construct building for the fulfillment of the objects of Trust for and on the behalf of the Trust; and

- (c) To acquire on lease, rent hire purchase, outright purchase any property or assets, movable or immovable for the benefit of the Trust or for Trust activities and to authorize any Trustees to formalize the deal including documentation in this regard, as also taking delivery or possession for and on the behalf of the Trust; and
- (d) To borrow money and raise funds bank, financial institutions and other bodies and to mortgage immovable and movable assets of the Trust to carry out objectives of the Trust; and
- (e) To sell, dispose off, replace, renovate, write – off any property or asset, movable or immovable, which is considered expedient in the overall interests of the Trust and to authorize Secretary and President of the Trust, jointly, to do needful, subject to direction of the Board of Trustees; and
- (f) To open and authorize operation of account(s) in the name of the Trust with such Bank/s and Post Office/s and at such places, as may be considered expedient; and
- (g) To ensure that trust Funds are duly invested, safely and soundly; and
- (h) To appoint, nominate or select other such Trustees with consent of all other Trustees whenever any vacancy arises; and
- (i) To invite any expert(s) or have his/her views, oral or in writing, on any matter pertaining to the affairs or object of the trust but such an invitee shall have no right to vote; and
- (j) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claim, demands and proceeding as and when expedient in the interest of the Trust Fund; and
- (k) To settle all accounts and to compromise, compound, abandon, or refer to arbitration an action or proceedings or disputes, claim, demand or

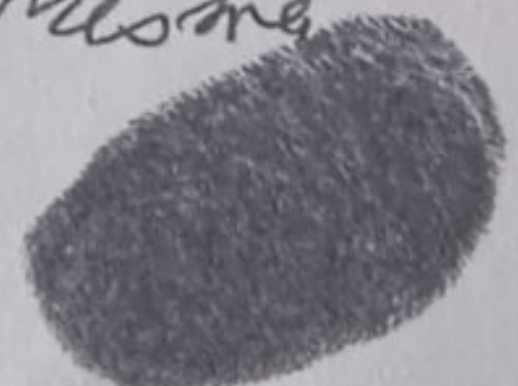

things as deemed proper for such purpose without being responsible for any loss occasioned hereby; and

- (l) To institute, contest or defend legal proceedings before any Authority vis – a vis the interest of the Trust; and
- (m) To appoint, employ, retain the services of any technical or specialized individual or laborer in furtherance of the objectives of the Trust on such salaries as deemed fit; and
- (n) To give aid by way donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trust in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain or carry out such charitable objects; and
- (o) To constitute and frame a separate Board of Management or Management Committee for effective and smooth implementation of each project launched/funded/sponsored by the Trust; and
- (p) To frame rules, regulations, guidelines, procedural formalities for regulating the proceeding of board and records, accounts, conduct of audit or on any matters not specifically provided for herein and likewise to repeal, amend, add or alter any such rules and regulations; and
- (q) To get help and assistance, whether financial or otherwise, from any Government, State, Local Bodies, Organizations, Foundations or Institutes for furthering trust's objectives; and
- (r) To collaborate and coordinate Trust's activities with other Trusts, Institutions, Organizations, bodies, etc. which are in consonance with Trust's objectives; and

- (s) To defray the expenses incurred in connection with the administration and activities of the Trust from the income generated from the Trust Fund and Trust Properties and in case the same are insufficient, from the Corpus of trust Fund, to the necessary extent; and
- (t) To pull down, renovate, rebuilt alter, adapt improve and to develop or repair any immovable properties comprised in trust Fund or the income thereof as they may think fit; and
- (u) To take over management of any trust or institution as carrying out the Trust under any deed or trust or Charitable bequests or legacies under any will or testamentary writings. On such terms and conditions if any, as may be thought fit by them in carrying out public charitable purpose the benefit whereof is not restricted to any class or community; and
- (v) To do all other such act/s and things as are consequential, incidental and/or conducive for the smooth administration and management of the affairs of the Trust.

11. That the trust shall open one or more Bank account in the name of the trust and the same shall be operate by Secretary.

12.Account & Audits:

- (a) The Board of Trustee shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses; and
- (b) The year of account shall be financial year commencing from 1st April to ending 31st March. However, the account for first year will close on 31st March irrespective of the date of commencement; and
- (c) The Board of Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts; and

- (d) The account of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the Board of Trustees and the audited statement of accounts together with Auditor's report shall be laid before the Board of trustees for approval.
13. No part of the Trust Fund, corpus or any other income there from or assets shall be utilized for any other purpose other than the object of the Trust.
14. The trustees shall attend to the trust's work in an honorary capacity, but nothing shall preclude the trustees to claim reimbursement of conveyance and travel expenses, stay and other expenditure incurred by them on account of Trust's work, attending its meetings, or representing, defending or instituting proceeding before the appropriate Authorities, on actual basis.
15. Founder trustee will be entitled to have remuneration for discharging his duty in as decided by Trustees.
16. In Trust forms a management committee for running institutions/or any other venture, The power of appointing and dismissing of member in such management committee will lie in hands of Trust.
17. **Liabilities of Trustees:** No Trustee shall be held liable for any act of omission or commission made in good faith, except when guilty of fraud, cheating, breach of trust or willful wrongdoing.
18. The Trustees shall be liable and responsible for their own individual willful acts and defaults not for the acts and defaults of any other person in whom Trust property is vested or who is looking after the affairs or management of the Trust.
19. **Amendment:** The Deed of Trust or any part thereof shall not be emended unless agreed upon by majorities of Trustees.

20. **Dissolution:** In case of failure of the Trust for want of object or other technicalities, or the functioning of Trust becomes impossible, then the Trustees unanimously may dissolve the trust and after meeting all liabilities, donate the remaining Trust & Corpus Fund to various organizations as near and as close to the objectives of the Trust or in accordance with the wishes of the Trustees.

21. **Proceeding of the Trust:** Any defect in the constitutions of the Trust shall not invalidate its proceedings.

22. **Residuary:** For matters not provided for in these presents, the provisions of the Indian Trust Act 1882, Charitable and Religious Trusts Act 1920 and Income Tax Act 1961 and rules & other proceedings made there under will apply accordingly.

23. The Trustees shall take steps immediately after the execution of these presents to register this trust with the Authority appointed by the Act governing public charities.

24. Words importing in this Deed of trust as masculine gender shall include the feminine and vice – versa.

25. As on the date the Trust is having no other movable or immovable assets except the cash mention above.
